This meeting of the Federal Council of the AMIEU resolves to alter the federally registered rules of the AMIEU in the following manner:

- (a) *In the **Table of Contents**: Replace reference to “South Australian Branch” [at p.35] with “South and Western Australian Branch”*
- (b) *In rule **13.1**, replace “the South Australian branch shall have five delegates (one of whom shall be the branch secretary)” with “the South and Western Australian branch shall have five delegates (one of whom shall be the branch secretary)”*
- (c) *In rule **13.2.3**, replace “South Australian Branch” with “South and Western Australian Branch”*
- (d) *In rule **16.1**, replace “the Assistant Branch Secretary of the South Australian Branch” with “South and Western Australian Branch”*

- (h) *In rule **26.9**, replace “a bargaining period that has been duly notified to the Australian Industrial Relations Commission” with “bargaining for an enterprise agreement or who wish to bargain for an enterprise agreement.”*
- (i) *In rule **26.10**, Replace “s.170ML of the Workplace Relations Act 1996” with “Part 3-3 of the Fair Work Act 2009”*

This meeting of the Federal Council of the AMIEU resolves to amend the federally registered rules of the AMIEU in the following manner

That Rules 47.5 of the Federal Rules of the AMIEU be amended as follows:

- (1) Delete the existing Rule 47.5.2 and 47.5.3 and replace with a new rule 47.5.2 that reads “Five(5) representatives from establishments other than supermarkets”; and*
- (2) Delete the existing Rule 47.5.4 and replace it with a new rule 47.5.4 that reads “Eight (8) representatives from Victorian regional areas.*

Accordingly, the new Rule 47.5 will read as follows:

47.5 As to the Metropolitan Area (for the purpose of this rule being an area extending to a 70 km radius of the GPO Melbourne) for the 2013 quadrennial Branch elections and onwards:

47.5.1 Six (6) representatives from Victorian supermarkets

47.5.2 Five (5) representatives from establishments other than supermarkets

47.5.3 DELETED

As to outside the Melbourne metropolitan area for the 2013 quadrennial Branch elections and onwards:

47.5.4 Eight (8) representatives from Victorian regional areas
